

Weekly Press Briefing Chambers and Registry N°3/2022 The Hague, 27/01/2022

Update

Welcome to the weekly press briefing of the Kosovo Specialist Chambers, where we aim to provide journalists with an update on the latest developments at the court, a look ahead at next week and the opportunity to ask questions.

On Friday, 21 January, Trial Panel I ordered the continued detention of Mr. Mustafa. The Judges found that the risk of obstructing the progress of proceedings continues to exist including the risk of interfering with victims and witnesses, and/or their families.

On 25 January 2022, the second last witness called by the Prosecution testified in the Salih Mustafa case about the chain of command, modalities of communications, and movements of the KLA in the Gollak/Goljak region. In addition, the witness testified about the BIA unit of the KLA and its role and functions in April 1999. He further gave evidence on the offensive of Serbian forces in the area of Zllash/Zlaš during the second half of April 1999. The witness testified without protective measures.

Next week, on 1 February 2022, the last witness called by the Prosecution is scheduled to start testimony in this case. On the 4th of February, the Prosecution is expected to close its case.

On 11 February, the Defence and Victims' Counsel will file their respective lists of witnesses and exhibits and, on 17 and 18 February 2022, Trial Panel I will hold a status conference in the presence of the Prosecution, the Defence, Victims' Counsel and the Registry in order to discuss the next phases of the case. Thereafter, the Panel will decide on the number and modalities of witnesses to be heard and on dates and times for the hearings.

In the case of Mr. Gucati and Mr. Haradinaj, the third witness called by the Haradinaj Defence testified on Friday, 21 January. The witness testified about the scope of the definition and the jurisprudence of whistleblowing.

The fourth witness called by the Haradinaj Defence started his testimony on Monday, 24 January, via video link. The witness testified about search and seizure operations at the ICTY. His testimony will continue on Friday, 28 January at 8:00 in the morning.

Following this testimony, the Panel will hear submissions from the Defence and the Prosecution on the next steps to be taken in this case.

In the Thaçi et al. case, on Tuesday, 25 January, a public redacted version of the Pre-Trial Judge's decision was filed, ordering the continued detention of Mr Thaçi. The Pre-Trial Judge found that the risk of the accused obstructing the proceedings or committing further crimes can only be sufficiently mitigated through the communication monitoring framework of the Specialist Chambers detention facilities.

The next pre-trial hearing in this case is scheduled for Friday, 4th February, at 2:30 in the afternoon.
