

Weekly Press Briefing Chambers and Registry N°19/2022 The Hague, 19/05/2022

Update

Welcome to the weekly press briefing of the Kosovo Specialist Chambers, where we aim to provide journalists with an update on the latest developments at the court, and the opportunity to ask questions.

The Trial Panel in the case against Mr Hysni Gucati and Mr Nasim Haradinaj pronounced the trial judgment yesterday, 18 May. This is the first trial judgment rendered by a trial panel at the KSC.

The Panel found Mr Gucati and Mr Haradinaj guilty of obstructing official persons in performing official duties, intimidation during criminal proceedings and violating the secrecy of proceedings. These are violations of the Kosovo Criminal Code and the Law on Specialist Chambers and the Specialist Prosecutor's Office. The Panel found the Accused not guilty of retaliation. The Panel sentenced each Accused to four and a half years' imprisonment, with credit for time already served, and a fine of 100 EUR each.

The Trial Panel found that in three press conferences, over 20 other media appearances and through social media posts the Accused revealed confidential information about protected witnesses and potential witnesses. They displayed the documents that contained it; allowed others to inspect, film, photograph, copy or take away the documents; and publicly described the documents' contents.

In addition to these acts, the Panel found that the Accused publicly called witnesses "traitors", "spies", "collaborators" and "Albanian-speakers" with the intent of making witnesses and potential witnesses fearful and therefore hesitant to provide information.

In pronouncing the trial judgment, the Panel emphasized that this case concerns the proper administration of justice, the integrity and security of proceedings and the safety, well-being and freedom from fear of hundreds of persons who have come forward to fulfil their civic duty as witnesses. The protection of witnesses from

intimidation and harm lies at the very foundation of any system of criminal justice, be that domestic or international. The Panel described the acts of the Accused as a challenge to that foundation and therefore a threat to justice.

Last week, the Registry managed a custodial visit for Hysni Gucati to Kosovo on the basis of compelling humanitarian grounds to meet immediate family, in accordance with a decision by the Trial Panel. During the visit, Mr Gucati remained in detention and in the custody of the Specialist Chambers. The public redacted decision by the Trial Panel on the visit is now available on the website of the Kosovo Specialist Chambers.

The trial of Mr Salih Mustafa continued this week with a hearing today. The Trial Panel has set Thursday, 26 May, as the target date for the closure of the Defence case.

In the case of Mr Hashim Thaçi and co-accused, the twelfth status conference has been scheduled for tomorrow, Friday, 20 May, starting at 14:30. Topics on the agenda include the process of disclosure, Defence investigations and next steps, and proposals to streamline the case.

All public hearings of the Kosovo Specialist Chambers are streamed online and can be followed in Albanian, Serbian, or English.
