

Weekly Press Briefing Chambers and Registry N°3/2023 The Hague, 26/01/2023

Update

Welcome to the weekly press briefing of the Kosovo Specialist Chambers, where we aim to provide journalists with an update on the latest developments at the court, and the opportunity to ask questions.

The Trial Panel in the Thaçi et al. case, after careful consideration of the parties' submissions, issued an "Order on the Conduct of Proceedings", which governs the conduct in the court room during trial, the disclosure process, the presentation and admission of evidence, the scheduling, questioning and cross examination of witnesses and other issues necessary to ensure fair and expeditious proceedings.

In this Order, the Trial Panel reminds the parties to respect the public character of the proceedings and emphasises that private sessions should only be requested where strictly necessary. Parties are asked to file all written submissions as public documents and to limit confidential matters as much as possible.

In regards to the authenticity and admissibility of evidence, the Trial Panel points out that it is the parties' responsibility to provide information regarding the origin of exhibits and what steps have been taken to verify the information. As such, the Trial Panel encourages the parties to set a high threshold for themselves when assessing the evidence that they intend to use during trial.

The Order remains subject to future variation by the Trial Panel, where necessary, as the trial progresses. The document is published on the KSC website.

In the case of Mr. Pjetër Shala, Trial Panel I partially granted the Defence's request to appeal certain parts of its decision to admit Mr. Shala's interviews with the ICTY in 2005 and 2007 as well as his interviews with Belgian authorities in 2016 and 2019 into evidence. In particular, the Panel granted Mr. Shala's request to appeal the Trial Panel's finding that he was sufficiently informed of the nature of the suspicion against him when he gave those interviews, and whether he was sufficiently informed when he waived his right to have access to a lawyer on those occasions.

In the case of Mr. Salih Mustafa, a public redacted version of the trial judgment has been published and is available on the KSC website.

In the case of Mr. Hysni Gucati and Mr. Nasim Haradinaj, the Appeals Panel will pronounce the appeal judgment on Thursday, 2 February 2023 at 14:00. The hearing can be followed in all three languages of the court through the streaming function on the KSC website with a short delay or from the KSC's public gallery.

Please note that pre-registration is required to follow the rendering of the appeal judgment from the public gallery. The deadline to pre-register is Tuesday, 31 January at 16:00.

In an effort to prevent the weekly press briefing from coinciding with the pronouncement of the Appeals Chamber's judgment, next week's press briefing will be held at 16:30 in the afternoon. Journalists can attend
