

Weekly Press Briefing Chambers and Registry N°30/2023 The Hague, 24/08/2023

## Update

Welcome to the weekly press briefing of the Kosovo Specialist Chambers, where we aim to provide journalists with an update on the latest developments at the court, and the opportunity to ask questions.

In the *Thaçi et al.* case, a redacted version of the "Fourteenth Registry Report on Victims' Applications for Participation in the Proceedings," originally submitted as confidential, was made public on 23 August and can be accessed on the KSC website. In the report, the Victims' Participation Office transmitted the applications of nine victims to the Trial Panel and recommended that they be admitted to participate in the proceedings as part of the existing group of participating victims.

In the same case, on 23 August, the Court of Appeals Panel denied an appeal by the Defence that had challenged the Trial Panel's decision to allow the SPO to admit evidence that has no direct connection to any of the witness testimonies.

Hearings in the *Thaçi et al.* trial resume next Monday, 28 August, at 09:00.

In the *Pjetër Shala* trial, Victims' Counsel presented its evidence earlier this week and a Defence preparation conference is taking place today and tomorrow. The Trial Panel had announced that among the issues to be discussed during the hearing are the status of the Defence investigation; the order in which the Defence intends to call its witnesses; whether the Defence will request protective measures for the witnesses; whether the Defence intends to request that witness 04 testify via video conference and if it intends to ask for the same measure for other witnesses as well; whether any of the witnesses will have to be examined away from the trial venue; whether any of the witnesses will need assurances against self-incrimination and if the Defence will need any hearings to be conducted in private session.

In the same case, the Trial Panel last week admitted into evidence a number of items, granting Prosecution, Defence and Victims' Counsel requests.

Last week an earlier decision related to the admission of evidence in this case was also made public. Specifically, in its decision of 4 July 2023, the Trial Panel admitted into evidence the written statements of five witnesses who are unavailable to testify in court, four of them because they are deceased. The Panel based its decision on the Rules of Procedure and Evidence and a determination for each of the written statements that, among other factors, the statement was reliable, that it was not prejudicial or inconsistent with the rights of the accused, and that it was relevant and authentic.

In the *Salih Mustafa* case, the Appeals Panel has scheduled an appeals hearing to take place on Thursday, 26 October 2023, starting at 13:30, and on Friday, 27 October 2023, starting at 9:30. According to the agenda, the hearing will include statements by the Presiding Judge and oral arguments from the Defence, the Prosecution and Victims' Counsel.
