

Weekly Press Briefing Chambers and Registry N°33/2023 The Hague, 14/09/2023

Update

Welcome to the weekly press briefing of the Kosovo Specialist Chambers, where we aim to provide journalists with an update on the latest developments at the court, and the opportunity to ask questions.

In the case of Hashim Thaçi, Kadri Veseli, Rexhep Selimi and Jakup Krasniqi, on Thursday, 7 September, the Trial Panel issued its seventh decision on victims' participation, admitting one new victim to participate in proceedings. The victim will be included in the existing group of participating victims and shall be represented by the same Victims' Counsel.

In its decision, the Trial Panel noted that the deadline for victims to apply to participate in the proceedings in this case was 15 February 2023. However, the Judges found that there was good cause to consider additional information and re-assess a resubmitted application from a previously denied applicant.

This brings the total number of participating victims in the case to 141.

In the same case, four witnesses testified so far this week in the trial hearings. The 22nd witness called by the Prosecution, Frederick Abrahams from the international NGO "Human Rights Watch", completed his testimony on Monday.

Following the completion of Mr. Abrahams testimony, the Prosecution called on Monday the next witness. The 23rd witness called by the Prosecution was a protected witness, whose testimony was conducted via video conference and mostly in private session.

The testimony of another protected witness, the 24th witness called by the Prosecution, commenced on Tuesday morning and continued on Wednesday. The witness is a Kosovo Albanian, who was a member of the LDK party as well as a member of the KLA in 1998-1999. After this witness's testimony concluded on Wednesday, the 23rd witness called by the Prosecution resumed his earlier testimony that had started on Monday, by video conference.

After this, on Wednesday afternoon, Douglas Young, a former UK Army officer serving in various international missions in Kosovo, began his testimony without protective measures. Mr. Young is the 25th witness called by the SPO so far.

The witnesses testifying this week were questioned by the Prosecution and cross-examined by the Defence teams. In addition, the Judges of the Trial Panel put questions to the witnesses.

Last Friday a public redacted version of an earlier decision of the Trial Panel from June of this year was issued. In the decision, the Trial Panel partially granted, with some conditions, a Prosecution request to admit into evidence statements and records from a number of witnesses.
